### Summary & Zone 1

- ☐ Hot Spots throughout the district. Pinnacle doing a good job with irrigation during the drought.
- □ Oak Trees need to be schedule to raise the canopy in Zone 3.

The following are action items for Pinnacle Landscapes to complete. Please refer to the item # in your response listing action already taken or anticipated time of completion. Red text indicates deficient from previous report. Bold Red text indicates deficient for more than a month. Green text indicates a proposal has been requested. Blue indicates irrigation. Orange indicates an issue to be handled by Staff and bold, underlined black indicates an update or question for the BOS.

- Zone 1 Penzance, Guardhouse & Paseo Grande
- Zone 2 Condos, west of Paseo Grande,
- Zone 3 Condos, east of Paseo Grande
- Zone 4 Rosalinda, Provencia, Mercado & Sarita (includes Bibiana to Emilia and Javiera to Nalda)
- Zone 5 Paseo Drive (starting at Paseo Grande and including bridge)
- Zone 6 Adelio, Dario & Adora
- Zone 7 Esteban, (both sides) & Macario
- Zone 8 Hidalgo, Falisto & Renata
- Remove a hanging frond on a Medjool Palm on the East end of Penzance after turning on from Palomino Ln.
- 2. Treat the weeds in the beds on the East end of Penzance in front of the lake.
- 3. Pitch Apple have been installed. They area good size and planted with correct spacing.
- There are several stumps within the beds along Penzance from removed trees. I suggest we flush cut to the ground unless the board would like to replace.
- 5. There are still a few hanging fronds on the Foxtail Palms on the West end of Penzance. Please have these removed.
- 6. Set a defined bed edge along West Penzance beds on the North ROW.

7. Treat the weeds in the beds on Penzance Blvd. West of the entrance. (Pic. 7)



- Remove the fruiting structures out of the Pygmy Date Palms on the West end of Penzance Blvd.
- 10. Remove any dead out of the Shell Ginger along Penzance Blvd. ROW beds.



- 11. Remove dead material within the Ligustrum trees along Penzance Blvd. West of the main entrance. Also, remove the sucker growth off the base of them.
- 12. There are 2 dead Red Ti in the bed on Penzance West of the main entrance. The area is across the street from Flintlock Ln. Please remove.
- 13. Annuals look nice and healthy on Paseo Grande Blvd. coming on from Penzance Blvd.
- 14. Diagnose and treat the 'Petit' Ixora on the median on Paseo Grande Blvd. just North of Penzance. Remove any diseased or dead material within them. There is one that needs to be removed you can see on the entrance side before you get to the gate. Are these in decline because to much water? What can be done to improve the health?
- 15. The Jatropha Trees were cut back on the median just South of the guard gate. I am noting these did not have clean cuts and may be susceptible to insect and diseases. (Pic. 15)



- 16. Treat the weeds within the pavers on Paseo Grande Blvd. as you enter the guard house.
- 17. Remove the Ball Moss in the bottom canopy of the Ligustrum in the island separating guest and residence at the guard house.

- 18. Remove a dead hanging branch within a Sycamore tree along the middle lake on the Eastside of Paseo Grande Blvd. close to the South gazebo.
- 19. Treat weeds in the Foxtail beds along the Eastside of Paseo Grande Blvd. Noting this is difficult to control without mulch. (Pic. 19)



- 20. Remove sucker growth on the Gardenia Standard at the Southeast gazebo.
- 21. Check the irrigation for coverage for the turf at the Southeast gazebo. There appears to be a dry spot just North of this gazebo. This was noted on the last report but has not greened up.
- 22. Remove the sucker growth off the Shady Lady trees on the Eastside of Paseo Grande Blvd. along the lake.
- 23. Diagnose and treat the declining and yellowing Petit Ixora along the sidewalk on the Eastside of Paseo Grande Blvd. close to the roundabout.
- 24. Treat ant mounds starting to show on the Eastside of Paseo Grande Blvd. between the sidewalk and the road from the roundabout North to the Northeast gazebo.
- 25. Declining St. Augustine in front of the Northeast gazebo. Diagnose and treat.



- 26. Pinnacle has done a good job treating the crack weeds on the walk path around the lake on Paseo Grande Blvd. Once these have died off, could you please clear off the tall ones.
- 27. Diagnose and treat the shrubs in front of the ramp on the North end of Paseo Grande Blvd. just West of Paseo Dr. (Pic. 27)



- 29. Large weeds showing on the North end of Paseo Grande Blvd. where the hurricane debris pile was at. Knock down with a mower or weedeater.
- 30. Remove sucker growth on Shady Lady trees on the West side of Paseo Grande Blvd. along the lake.
- 31. Diagnose and treat the St. Augustine just north of the Northwest gazebo on Paseo Grande Blvd. between the walk path and the road. Possible insect damage.
- 32. Remove the sucker growth on the Gardenia Standard at the Northwest gazebo on Paseo Grande Blvd.
- 33. Treat the weeds in the pavers for the parking spots on the West side of Paseo Grande Blvd.
- 34. Treat the ant mound on the roundabout on the West side of Paseo Grande Blvd.

35. Treat the weeds in the Palm bed on the West ROW of the Westside of Paseo Grande Blvd. near the roundabout. (Pic. 35)



- 36. Remove dead hanging branches in the Sycamore tree along the lake bank on the Westside of Paseo Grande Blvd. between the 2 gazebos.
- 37. Noting that the Ixora and Crotons in both roundabouts on Paseo Grande Blvd. appear to be much healthier and are now thriving.
- 38. Diagnose and treat the declining and yellowing Petit Ixora along the sidewalk on the Westside of Paseo Grande Blvd. close to the roundabout. (Pic. 38)



39. Diagnose and treat declining St. Augustine at the Southwest gazebo.



- 1. Treat the weeds in the Foxtail Palm beds along Bibiana Way.
- Possible insect damage on the South ROW of Bibiana Way just West of Paseo Grande Blvd. Diagnose and treat as necessary. (Pic. 2)



- 3. Remove one dead hanging frond on a Foxtail on the South ROW of Bibiana Way in front of the East pond.
- 4. Treat the weeds within the Ixora and Bougainvillea bed on the South ROW of Bibiana.
- 5. Pin down bubblers that are sticking up on some of the Foxtail beds between the walk path and the road on Bibiana Way.
- Remove vines growing on top of the Ficus hedge on the corner of Bibiana Way and Emilia St.
- Just noting that the water valve encased in concrete is still sitting on the North ROW of Bibiana Way.
- 8. Diagnose and treat possible insect damage in the St. Augustine on Esperanza St.
- 9. Treat the ant mounds West of the mailbox kiosk on the North ROW of Bibiana Way.

- 10. Weeds in most of the tree beds in Zone 2. Treat as necessary.
- 11. The hog damage within Zone 2 has been leveled out and mowed. It is starting to fill in with St. Augustine runners.
- 12. Treat the crack weeds in the park spots along Adoncia Way.
- 13. Remove large weed in shrub bed at the mailbox kiosk on Adoncia Way. (Pic. 13)



- 14. Continue to monitor the Foxtail Palms in zone 2 and update the district on any that will need replacement.
- 15. Pinnacle has done a good job with irrigation on hot spots in zone 2. There are a couple that are showing along the lake bank of Emilia. Double check the coverage.
- 16. Remove a large rock within the 2<sup>nd</sup> Foxtail bed just West of Paseo Grande Blvd. on the North ROW of Adoncia Way.
- 17. Treat the weeds in the pavers on the walk path on the North ROW of Adoncia Way West of Tulio Way.
- 18. Noting on Tulio Way there are a couple piles of clippings on the East ROW just South of Adoncia Way. Just remember to smooth out.



- Continue to monitor the Foxtail Palms in zone 3 and update the district on any that will need replacement.
- 2. Raise and prune back the Oak trees on Palba Way between Izarra Way and Olinda Way. They are growing over the street and are low enough to possible scratch vehicles. (Pic. 2)



- Clean the Crinum Lily at the mailbox kiosk on Palba Way between Olinda Way and Herminia St.
- 4. Remove large palm frond that has fallen on the aluminum fence on Palba Way that shares the ROW with Penzance.
- 5. Raise and prune the Oak trees on Izarra Way between Melosia St. and Nalda St. (Pic. 5)



- 6. Remove the Oak suckers at the base of the tree on Izarra Way on the East ROW.
- 7. Treat broadleaf turf weeds on the North ROW of Izarra Way just East of Paseo Grande Blvd.
- 8. Raise the Oak canopy on Olinda Way just before you get to Izarra Way that is blocking the signage.
- Diagnose and treat the declining small tree on the North ROW of Nalda St. across from Liana St.
- 10. Turf is looking better and filling in at the lift station on the intersection of Nalda St. and Javiera Way. May need a few plugs to help it along.
- 11. Raise the low Oak canopy on Nalda St. just North of Oliveria St. (Pic. 11)



- 12. Remove the Oak sucker growth on the ROWs of Javiera Way.
- 13. Treat the weeds in the Foxtail beds on Javiera Way between Nalda St. and Paseo Grande Blvd.



 Diagnose at treat the 'Petit' Ixora looking off color or possibly chlorotic at the Rosalinda monument. This was on the last report and stated it was treated but they are getting progressively worse. (Pic. 1)



- Remove dead fronds in the Paurotis Palms at the Felisa Ct. roundabout.
- Remove the Mexican Petunia growing within the Variegated Arboricola on the Felisa Ct. roundabout.
- 4. Treat the sedge and broadleaf weeds within the turf on the Felisa Ct. roundabout.
- 5. Remove the sucker growth of the base of the Ligustrum Tree at the Rosalinda roundabout.
- 6. Diagnose and treat the St. Augustine turf for possible insect damage or check irrigation coverage for Provencia monument. (Pic. 6>)
- 7. Diagnose and treat the yellowing 'Petit' Ixora a the Provencia monument.
- 8. Check the irrigation for coverage and time and the Provencia roundabout.
- 9. Remove dead Paurotis Palm fronds at the Provencia roundabout.
- 10. Treat bed weeds at Mercado entrance.

11. Remove the large seed pods on the Royal Palms on Sarita Ct. roundabout.





- Red Hot Hibiscus south of the bridge on the East and West ROW on Paseo Dr. is slow to flush out. They could use extra fertilizer to help them along.
- Diagnose and treat the Copperleaf on the West ROW of Paseo Dr. South of the bridge.




 On the West ROW of Paseo Dr. South of Adelio Ln. there are hanging fronds in the Bismark Palm that need removal. (Pic. 3)



- Just North of the bridge on the East ROW there are a few Croton that look diseased. These are not getting better. Diagnose and treat.
- 5. Treat the bed weeds on the East ROW of Paseo Dr across from Adelio Ln. Also, define the bed line here.

- There are also nicked hanging fronds on the Medjool Palm and Coconut Palms north of the bridge on Paseo Dr. near Adelio Ln. Please remove.
- 7. What can be done to improve the health of the Mammy Croton in the bed on the Southwest corner of Paseo Dr. and Adelio Ln? Should we replace with a different species that will thrive in this area?
- The Awabuki hedge on the East ROW of Paseo Dr. does not appear to be flushing out new growth yet. Does this need to be retreated? (Pic. 8)
- 9. Treat the weeds around the Bromeliads on the East ROW of Paseo Dr. between Adelio Ln. and Dario Way. (Pic. 9)



- 10. Dead Bismark on the West ROW of Paseo Dr. South of Dario Way. Has this proposal been approved for removal?
- 11. Diagnose and treat the Awabuki on the South ROW of Paseo Dr. just South of Esteban Dr. by the electric meter.
- 12. Dead hanging Coconut palm fronts on both the North and South ROWs on Paseo Dr. at the Esteban Dr. intersection.
- 13. Prune the spike growth on the Gold Mound on Paseo Dr. just East of Esteban Dr.



- 14. Diagnose and treat the St. Augustine turf on the North ROW of Paseo Dr. just West of Esteban Dr. along the walk path.
- 15. Remove the sucker growth off the newly installed Jatropha Standard on Paseo Dr. North ROW between Esteban Dr. and Hidalgo Ct.
- Diagnose and treat the declining Gold Mound on Paseo Dr. North ROW between Hidalgo Ct. and Falisto Pl.
- 17. Remove the Bismark Fruiting structures on Paseo Dr. North ROW between Hidalgo Ct. and Falisto Pl. (Pic. 17)



- 18. What is the status of the proposal for the Pitch Apple on the South ROW of Paseo Dr. from previous reports where there are 6 dead ones just East of Hidalgo Ct?
- 19. Straighten the Eastern most newly planted Jathropha tree on the North ROW of Paseo Dr. between Falisto Pl. and Renata Ct.
- 20. Check the irrigation on Paseo Dr. roundabout for coverage and time. (Pic. 20>)





 The irrigation does not appear to be working at the Adelio Ln. roundabout. Correct ASAP. I also left a voice message for Pinnacle as soon as I saw this. (Pic. 1)



- 2. Three Shady Lady trees on the North ROW on Dario Way are leaning. Can these be straightened and staked where needed? What is the status for doing this?
- Raise a couple limbs on the Shady Lady trees on the North ROW on Dario Way that are close to the ground.
- 3. Treat the bed weeds in the roundabout on Adora Ct.
- 4. Treat the weeds growing under the Bougainvillea at the Dario Way roundabout.
- 5. Remove the dead Paurotis Palms at the Dario Way roundabout.



- 1. Treat the weeds in the bed on Marcario Ct. roundabout.
- Continue to monitor the Bismark Palm at the Macario Ct. roundabout. It appears it will survive. Do need to remove a dead hanging frond here. (Pic. 2)



- 3. Check the irrigation coverage for small hot spot on Macario Ct.
- 4. Treat weeds in the bed at the roundabout on Esteban Dr. South roundabout.
- 5. Check the irrigation on Esteban Dr. South on the Westside by the lift station. (Pic. 5)



1. The Bismark Palm on the Hidalgo roundabout appears that it will not survive. What is the status for a proposal to remove?



- 2. Mound of dirt on the Hidalgo roundabout that needs to be smoothed out.
- 3. Hot spot and possibly chinch bug activity at the Falisto PI. Please check the irrigation coverage.
- 4. Diagnose and treat the Bird of Paradise at the Falisto Pl. roundabout.
- 5. Check the irrigation coverage for a hot spot at the Renata Ct. roundabout.
